**Description:** Human C-Peptide, lyophilized (white powder).

**Formulation:** Lyophilized from a solution containing Tris, NaCl, Kathon, BSA, Dextran-10.

**Storage:** Store at +4°C.

**Stability:** This product is stable for at least 12 months from the manufacturing date when stored in its original packaging and the recommended storage conditions.

**Reconstitution:** Reconstitute human C-Peptide in 100 µL Milli-Q® grade H<sub>2</sub>O and aliquot if required.

Aliquots should be stored in screw-capped polypropylene vials at -20°C. Reconstituted human C-Peptide is stable for at least 75 days at -20°C. Avoid multiple freeze-thaw cycles.
